Actions required in Netsuite

There is specific custom record GS Tax codes. Records determinates the codes in the Bezala Netsuite integration. The record does not support decimal currently. Please do the following action to fix the record to support to decimal.

Part 1 – Download bundle

- 1. Navigate to: Customization>SuiteBundler>Search & Install bundles
- 2. Type in the keywords: 533828 and press search
 - a. You will see bundle named as GS Tax code fix as in picture below

Note that you need to add the code for all Finnish subsidiaries who are using Bezala.

Actions required in Bezala

If your company is using Tax Codes in Bezala (is in use if VAT code / ALV-koodi field is visible in Bezala), the new Tax Codes have to be added to Bezala too. If they are not used, new VAT percent does not require actions in Bezala's end.

We also recommend renaming the old Tax Codes so that they can be so that they can be distinguished from each other (i.e. add new VAT 25, code as "S-FI" and rename old as "S-FI 24%").
